Article 38(1) of the Statute of the International Court of Justice lists "international custom, as evidence of a general practice accepted as law," or in short customary international law (CIL), as one of the three principal sources of international law. ¹ In recent years the International Law Association (ILA) and International Law Commission (ILC) have undertaken the task of clarifying rules concerning the formation and identification of CIL.

Customary International Law: A Third World Perspective

Perhaps the field where this rings most true is that of 'customary international law'. Despite appearing in treaties, international court decisions, and United Nations resolutions (and in fact being older than the United Nations itself), customary international law is a concept rarely discussed in mainstream public discourse. Yet it has profound consequences for the international rule of law.

According to ALI, customary international law "results from a general and consistent practice of states followed by them from a sense of legal obligation." You can generally identify international customary law by checking three elements: (1) consistent state practice, (2) widespread (or general) state practice, and (3) a sense of obligation.

Summary State practice establishes this rule as a norm of customary international law in international armed conflicts. For purposes of the principle of distinction (see Rule 1), members of State armed forces may be considered combatants in both international and non-international armed conflicts.

It is the customary rule of International law that treaties should be performed by the states in good faith which is also evident in the United Nations Charter under Article 2 which states that Members

are required to perform their obligations in good faith as stated in the charter. The principle is based on the most basic fundamental rule of International law that treaties are meant to be performed by the ratifying states and it should be taken care that states do not take their ...

The need for international protection arises because they are unable to avail themselves of the protection of their own country against these threats. International refugee law derives from a range of treaties (universal and regional), rules of customary international law, general principles of law, and national laws and standards.

The persistent objector rule is said to provide states with an 'escape hatch' from the otherwise universal binding force of customary international law. It provides that if a state persistently objects to a newly emerging norm of customary international law during the formation of that norm, then the objecting state is exempt from the norm once it crystallises into law.
