Although a complaint should usually be made within 12 months, there is a three-year time limit (from the time you become aware of the medical negligence) to make a legal claim for compensation.

However, if a person who has been affected by medical negligence is aged under 18 years at the time, the three-year limit starts on their 18th birthday.
