The legal system will be adequate in extreme cases of obvious violations of this principle, which require criminal sanctions; however, in most cases, and under the condition that there is no intent to violate the principle of

proportionality, a moral system that requires adequate moral deliberation will achieve much better consequences, as it demands that the commander weigh the relevant facts but does not expect a clear-cut solution when such is impossible.
