Criminal law varies according to jurisdiction, and differs from civil law, where emphasis is more on dispute resolution and victim compensation, rather than on punishment or rehabilitation. Criminal procedure is a formalized official activity that authenticates the fact of commission of a crime and authorizes punitive or rehabilitative treatment of the offender .

There are two significant differences between the two court systems: the burden of proof necessary, and the role of the victim in each process. In a criminal case, conviction requires "proof beyond a reasonable doubt.". In a civil case liability must be proven by a preponderance of the evidence. In a criminal case the state controls the proceedings and the victim acts as a witness for the prosecution.
