CORPORATE RESOLUTION OF SIGNING AUTHORITY. RESOLUTION OF:

RESOLVED that the execution of Deeds, powers of attorney, transfers, assignments, contracts, obligations, certificates, and other instruments of whatever nature entered into by the Company directly or through a transfer agent or registrar for any stock company, acting in its capacity as a corporate director or exercising any and all other powers conferred upon it by the letters Patent incorporating it ...

Corporate Resolution of Signing Authority

Signatures of officers designated to sign corporate resolutions--usually the board chairperson or the corporate secretary; Title the document with its purpose. For

example, "Resolution to Accept Bank Depository." A phrase stating that the resolution has the consent and agreement of the board members.

What to Include in a Corporate Resolution

The following is a template of board resolution for authorising an official to sign an agreement. SAMPLE #1. #. Authorisation to execute an agreement with M/s. "RESOLVED THAT the consent of the Board of Directors be and is hereby given for execution of a agreement, as per the draft of the agreement tabled before the meeting and initialed by the Chairman for purposes of identification, to be entered into between the Company and M/s.

Format of Board Resolution for Authorisation to Sign Agreement

A certified corporate resolution is a resolution made at a directors' or shareholders' meeting that has been approved by the secretary and president of the corporation. This type of resolution is useful if a bank or other external organization ever requires verification to permit specific actions or powers, such as the authority to sign documents on behalf of the corporation.
