(d) If a party objects to the discovery of electronically stored information on the grounds that it is from a source that is not reasonably accessible because of undue burden or expense and that the responding party will not search the source in the absence of an agreement with the demanding party or court order, the responding party shall identify in its response the types or categories of ...

California Code, Code of Civil Procedure - CCP § 2031.210

...

(A) Time to Respond. The party to whom the request is directed must respond in writing within 30 days after being served or — if the request was delivered under Rule 26(d)(2) — within 30 days after the parties' first Rule 26(f) conference. A shorter or longer time may be stipulated to under Rule 29 or be ordered by the court.

Even if the taxpayer doesn't have the requested documents, or if they are already in the possession of the IRS, such response should be put in writing. Asking Corporate Defendant for Individual's Documents This request requires Deponent, as an individual, to search Company files, computers and records for responsive documents. Documents that are the property of Company are not within the Deponent's individual possession, custody or control. Res Judicata, Collateral Estoppel and Arbitration

Practice Guidance: Objections to Discovery Requests ...

The California Code of Civil Procedure now requires " [a]ny documents or category of documents produced in response to a demand for inspection, copying, testing, or sampling shall be identified with the specific request number to which the documents respond." Cal. Civ. Pro. § 2031.280 (a). This is a major departure from the prior rule.

CCP 2031.280(a): New Document Production Obligations in ...

If the responding party objects to the demand, the response shall do both of the following: (1) Identify with particularity any document, tangible thing, land, or electronically stored information falling within any category of item in the demand. (2) Set forth clearly the extent of, and the specific ground for, the objection.
