At least 3 credit hours - in funeral directing ethics and in New Jersey law and rules relating to the practice of mortuary science. The three credit hours shall require in-person attendance; A licensee may obtain no more than three credit hours in each biennial licensing period in courses or programs dealing with funeral merchandising, such as caskets, outer burial containers and clothing.
