In a global economy where multinational enterprises (MNEs) play a prominent role, transfer pricing is high on the agenda of tax administrators and taxpayers alike.

Of the 38 survey respondents, 36 indicated the comparable uncontrolled price/transaction (CUP/CUT) method as the most common transfer pricing methodology adopted for intercompany licensing transactions. When applied, the CUP method relies on internal comparables or more often on database studies for external comparable license agreements.

The TNMM is one of two transactional profit methods outlined by the OECD for determining transfer pricing. These types of methods assess the profits from particular controlled transactions.
