The Metaphysics of the Material World *Oxford University Press, USA*

In *The Metaphysics of the Material World*, Tad M. Schmaltz traces a particular development of the metaphysics of the material world in early modern thought. The route Schmaltz follows derives from a critique of Spinoza in the work of Pierre Bayle.

Bayle charged in particular that Spinoza's monistic conception of the material world founders on the account of extension and its "modes" and parts that he inherited from Descartes, and that Descartes in turn inherited from late scholasticism, and ultimately from Aristotle. After an initial discussion of Bayle's critique of Spinoza and its relation to Aristotle's distinction between substance and accident, this study starts with the original re-conceptualization of Aristotle's metaphysics of the material world that we find in the work of the early modern scholastic Suárez. What receives particular attention is Suárez's introduction of the "modal distinction" and his distinctive account of the Aristotelian accident of "continuous quantity." This examination of Suárez is followed by a treatment of the connections of his particular version of the scholastic conception of the material world to the very different conception that Descartes offered. Especially important is Descartes's view of the relation of extended substance both to its modes and to the parts that compose it. Finally, there is a consideration of what these developments in Suárez and Descartes have to teach us about Spinoza's monistic conception of the material world. Of special concern here is to draw on this historical narrative to provide a re-assessment of Bayle's critique of Spinoza.

Siddhartha □□□

Siddhartha is a 1922 novel by Hermann Hesse that deals with the spiritual journey of self-discovery of a man named Siddhartha during the time of the Gautama Buddha. The book, Hesse's ninth novel, was written in German, in a simple, lyrical style. It was published in the U.S. in 1951 and became influential

during the 1960s. Hesse dedicated the first part of it to Romain Rolland and the second to Wilhelm Gundert, his cousin. The word Siddhartha is made up of two words in the Sanskrit language, siddha (achieved) + artha (what was searched for), which together means "he who has found meaning (of existence)" or "he who has attained his goals". In fact, the Buddha's own name, before his renunciation, was Siddhartha Gautama, Prince of Kapilvastu. In this book, the Buddha is referred to as "Gotama".

Relying on both interviews with residents and archival research, Bruce D. Haynes describes the progressive stages in the life of the community and its inhabitants and the factors that enabled it to form in the first place and to develop solidarity, identity and political consciousness. He shows how residents came to recognize common political interests within the community, how racial consciousness provided an axis for social solidarity as well as partial insulation from racial slights, and how the suburb afforded these middle-class residents a degree of physical and social distance from the ghetto. As Haynes explores the history of Runyon Heights, we learn the ways in which its black middle class dealt with the tensions between the political interests of race and the material interests of class.

One Artist, One Material *Frame Publishers*

Divided into six chapters, fifty-five artists

talk about their material of choice. Does living in the digital age intensify our relationship with the material world? The success of *One Artist, One Material*, a regular feature section that has appeared in *Frame* magazine for over a decade, suggests that it does. An interview with a maker about his or her chosen material, it first appeared in *Frame* 65 (May/June 2007) and is still going strong. This book contains 55 of those interviews. Within the deceptively simple formula, dramatic, amusing, perplexing and humbling stories unfold. A material's simplicity often bears no relation to the complexity it expresses in the hands of a creator. Magpie feathers are shaped into disturbing spatial deluges by Kate McGwire; white balloons are used over and over again by Charles Pétillon to undermine our perceptions of everyday reality. Over *One Artist, One Material's* lifetime, art and design have been steadily converging, with pop-up shops now often appearing to be art installations (and occasionally vice versa). Pressures on budgets and increasing awareness of sustainability issues have led designers to take a new look at materials, opting for recycling, making, and even growing their own. Handcrafted items have meanwhile found a new popularity and relevance. All of these material trends are prefigured in *One Artist, One Material*.

Exploring and Treating Acquisitive Desire *SAGE Publications, Incorporated*

This book demonstrates how what we own can control us - the terminal stage of the social disease of acquisitive desire for material things. Topics covered include: what acquisitive desire means in people's lives; diagnosis and treatment of consumer disorders; interventions and clinical issues for those who follow an excessively materialistic lifestyle; how therapists and therapy are treated as possessions to flaunt; and the struggles of therapists with their own acquisitive desires. Jeffrey Kottler does not recommend giving up all attachment to things, but makes clear that satisfaction comes not from owning possessions, but from their legitimate use for amusement, stimulation or learning.

The Long Revolution *Broadview Press*

Raymond Williams, whose other works include *Keywords*, *The Country and the City*, *Culture and Society*, and *Modern Tragedy*, was one of the world's foremost cultural critics. Almost uniquely, his work bridged the divides between aesthetic and socio-economic inquiry, between Marxist thought and mainstream liberal thought, and between the modern and post-modern world. When *The Long Revolution* first appeared in 1961, much of the acclaim it received was based on its prescriptions for Britain in the '60s, which form a relatively brief final section of the whole. The body of the book has since come to be recognized as one of the foundation documents in the cultural analysis of English-speaking culture. The "long revolution" of the title is a cultural revolution, which Williams sees as having unfolded alongside the

democratic revolution and the industrial revolution. With this book, Williams led the way in recognizing the importance of the growth of the popular press, the growth of standard English, and the growth the reading public in English-speaking culture and in Western culture as a whole. In addition, Williams's discussion of how culture is to be defined and analyzed has been of considerable importance in the development of cultural studies as an independent discipline. My Kid Brother's Band A.k.a. the Beatles

As a record 73 million viewers watched the Beatles American debut on The Ed Sullivan Show a half-century ago, the audience was largely unaware of the behind-the-scenes efforts in the preceding weeks and months that made the historic Feb. 9, 1964 performance a reality. Those efforts were spearheaded by Louise Harrison—sister of guitarist George Harrison—from her home in a small town in southern Illinois. In *My Kid Brother's Band a.k.a. The Beatles* Louise describes her tireless efforts to help promote the Beatles—who were already household names in England—and their records on this side of the Atlantic. *My Kid Brother's Band a.k.a. The family principles, Louise says, helped to guide Harrison and the band through their unprecedented success during the '60s and through George's solo career. "It's important for you to know more about our parents and our upbringing," writes Louise, "so you can better understand how (George) became the man you love and admire." The book contains dozens of photos of George and the Beatles, as well as images of correspondence documenting her communication with Epstein and with radio and recording industry executives as she worked to give the group exposure in the months leading up to the landmark Sullivan appearance.
