Negligence Duty Of Care Law

Duty of care refers to the circumstances and relationships which the law recognises as giving rise to a legal duty to take care. A failure to take such care can result in the defendant being liable to pay damages to a party who is injured or suffers loss as a result of their breach of duty of care. Therefore it is necessary for the claimant to establish that the defendant owed them a duty of care.

Negligence is usually focused on proving: The defendant owed a duty of care to the claimant (= person bringing the claim); The defendant must have breached that duty of care; and. The claimant suffered damage as a result. If any one or more element of the above is missing the defendant is not negligent.

For a claim in negligence to succeed, it is necessary to establish that a duty of care was owed by the defendant to the claimant, that the duty was breached, that the claimant's loss was caused
