Travel Expense Guidelines

You figure the deductible part of your air travel expenses by subtracting 7 / 18 of the round-trip airfare and other expenses you would have had in traveling directly between New York and Dublin ($\$1,250 \times 7 / 18 = \486) from your total expenses in traveling from New York to Paris to Dublin and back to New York ($\$750 + \$400 + \$700 = \$1,850$).

Publication 463 (2019), Travel, Gift, and Car Expenses ...

This travel must be overnight and more than 100 miles from your home. Expenses must be ordinary and necessary. This deduction is limited to the regular federal per diem rate (for lodging, meals, and incidental expenses) and the standard mileage rate (for car expenses) plus any parking fees, ferry fees, and tolls.

As part of the traveler's expense reimbursement documentation, written approval from the Principal Investigator (PI) of the expense report will be required for any travel charged to a federal grant or contract. Submitted expense reports with charges to a federal grant are reviewed by Post-Award Financial Operations (PAFO) on a quarterly basis.

Business Travel Expense means reasonable, appropriate, and necessary travel expense incurred while carrying out University business and incurred while on travel from one's office to a business destination and back. Cash Advance is defined as funds given to a Traveler prior to the trip for expenses incurred while on University business.
