In his book, *Collective Labour Law in Botswana* 23, Professor Justice Oagile Key Dingake states that the Industrial Court replaced the institution of the Permanent Arbitrator following the enactment of the Trade Disputes Act (No. 23/1997). According to the Veronica Moroka case supra, this Act came into force on 9 th October 1997.

... Industrial Court. The Industrial Court is a Court of Law and Equity, created by section 14 of the Trade Disputes Act No.6 of 2016. the Court has exclusive judgments in all labour disputes and ranks equal to the High Court in its status and power. Its judgments are

appealable to the court Appeal. The Magistrate Court. The Magistrate court are created by statute with power defined by the Magistrates Courts Act. They are subordinate to the High Court.

STRUCTURE OF COURTS IN BOTSWANA - WikiEducator

As the Industrial Court is not only a court of law but also a court of equity, it applies rules of natural justice, or rules of equity as they are sometimes called, when determining trade disputes. These rules of equity are derived from conventions and recommendations of the International Labour Organisation (ILO).
