Both relative intensity quantitation of EPR samples and their absolute spin concentration of samples are often of interest. This information is important for kinetics, mechanism elucidation, and commercial applications where EPR serves as a detection system for free radicals produced in an industrial process. It is also important for the study of magnetic properties. Magnetic field/microwave frequency is important for g and nuclear hyperfine coupling measurements that reflect the electronic structure of the radicals or metal ions.
