This means, for example, that if you've worked for your employer for 22 years you'll only get redundancy pay for 20 of those years. The maximum weekly amount used to calculate redundancy pay is £538 – even if your wage is more per week.

Statutory Redundancy pay is set down by law, and is the minimum that employees who have been made redundant can expect to be paid by their employer. The amount of money you will be paid for Statutory Pay depends on

several things including (i) how long you have worked for an employer; (ii) your age; and (iii) your weekly pay.
