State Farm Insurance Co. found that the insured's cause of action against the insurer was based on

bad-faith liability due to an excess judgment attributable to punitive damages, the recovery of which would violate New York's public policy, which precluded indemnification for punitive damages generally. 9 Permitting such a recovery would improperly focus on the insurer's alleged wrongful act in refusing to settle while minimizing the insured's own blameworthy conduct.

No motion to dismiss the contract claim was asserted, but the insurer did move to dismiss the insured's bad faith claim and request for punitive damages. The bad faith count included allegations that the insurer "(1) failed to properly and promptly investigate Plaintiff's claims; (2) denied and delayed her coverage with no debatable reason to do so; (3) violated the Unfair Claims Settlement Practices Act; and (4) unreasonably denied adjusting and paying Plaintiff's claim."

Whether an insurer's bad faith subjects it to punitive damages is governed by the

familiar standards applicable to other torts and set forth in O.C.G.A. § 51-12-5.1.71 Under that statute, punitive damages may be awarded only when it is proven by "clear and convincing evidence" that the defendant's actions showed "willful misconduct, malice, fraud, wantonness, oppression, or that entire want of care which would raise the presumption of conscious indifference to consequences."
