ARTICLE Law and Policy of Targeted Killing

Targeted killing as law enforcement should only be admissible as lawful if it '(a) aims at preventing an unlawful attack by the targeted person on human life; (b) is absolutely necessary for the achievement of this purpose; and (c) is the result of an operation which is planned, prepared, and conducted so as to minimize, to the greatest extent possible, the recourse to lethal force'. 94 Any possible legality of such forms of targeted killings as law enforcement is seriously doubted by ...
