The "law of the case" doctrine precludes reconsideration of a previously decided issue unless one of three "exceptional circumstances" exists: (1) when substantially different evidence is raised at a subsequent trial, (2) when a subsequent contrary view of the law is decided by the controlling authority, or (3) when a decision is clearly erroneous and would result in a manifest injustice.

Case law is the collection of past legal decisions written by courts and similar tribunals in the course of deciding cases, in which the law was analyzed using these cases to resolve ambiguities for deciding current cases. Modern law reports aim to provide accurate full text records of judicial decisions and reasoning in cases that have legal value as precedents. They are

dominated by cases from the higher courts and very rarely feature cases settled in the lower courts and tribunals.

Modern law reports and legal cases - The British Library

Case law is the law created by the courts. Although most laws are enacted by Parliament in the form of legislation, in a common law system such as ours the courts can also develop the law. By deciding a disputed point of law a senior court (known as a court of record) can change or clarify the law, thereby setting a precedent which other courts are bound to follow or apply in later cases.
