Presented by Patricia Bowyer, EdD, MS, OTR, FAOTA; Hany Ngo, MOT, OTR; and Jessica Kramer, PhD, OTR Earn .6 AOTA CEU (7.5 NBCOT PDUs/6 contact hours) Course Description Introducing practitioners to The Short Child Occupational Profile (SCOPE) assessment tool, this new continuing education course provides occupational therapy professionals with a systematic way to document a child's motivation for occupations, habits and roles, skills, and environmental supports and barriers. In a holistic approach to documenting a child's occupational strengths and challenges, the SCOPE enables practitioners to focus on participation and can be used with children and youth ages birth to 21 in a range of practice contexts, such as school, home, inpatient and community practice settings. With ratings based on each child's unique developmental trajectory, SCOPE can capture the strengths and challenges of children of all abilities. Presented in 2 parts with specific learning objectives for each, Part I introduces the theoretical concepts underlying the SCOPE and presents several methods for gathering information for ratings and familiarizes practitioners with the SCOPE rating scale and items. A video case has been included along with a written case summary. Part II examines goal writing and the application of the SCOPE and builds on the video case study presented in Part I. Participants will be able to interpret the SCOPE rating, use the knowledge to develop goals and interventions that are theory

based and occupation centered, and become familiar with resources that support participation-focused goal-writing and planning interventions based on the Model of Human Occupation. The SCOPE is required text for successful completion of the course and is included in the content. It may be printed in its entirety or by sections as needed.

Analyzing Children's Art *Girard & Stewart*

Drawing from her study of approximately one million drawings by children, Rhoda Kellogg traces the mental and artistic development of children from infancy to eight years of age, defining and classifying the forms common to children's art throughout the world. Kellogg renders a realistic account of children's art in a variety of media and demonstrates how and why their art develops over time. Incorporating ample visual examples and detailed analyses, this widely cited study provides the essentials to identifying cognitive development and educational needs evidenced in children's art. An indispensable guide for teachers and counselors specializing in early education, *Analyzing Children's Art* demonstrates how art plays an undeniably important role in a child's mental growth. Rhoda Kellogg (1898-1987), nursery school educator and collector of over one million children's drawings, earned a bachelor's degree

from the University of Minnesota and a master's degree from Columbia University. Over half of her collection is archived in the Rhoda Kellogg Child Art Collection of the Golden Gate Kindergarten Association. In 1967, Kellogg published a groundbreaking archive of approximately 8,000 drawings by children from the ages of 20 to 40 months and thus became the

first to publish an archive of early graphic expressions. As an author, Kellogg applies an in-depth classification system to children's art and emphasizes the development of formal design, which plays a critical role in relation to pictorialism.
