A resolution adopted by a limited liability company, or LLC, represents the majority decision of the owners of the company on a matter presented for consideration. An LLC is a hybrid business entity that enjoys the operational flexibility of a partnership, but unlike a corporation, doesn't have to follow a particular procedure by law to pass a resolution.

LLC Basics. Business owners form their company's legal structure as a limited liability company, or LLC, for a variety of reasons, one of which is that state LLC laws do not require that the LLC be run with the formality of a corporation. This means that an LLC does not have to hold regular meetings, keep minutes of meetings or document company action in the form of a written resolution.

A Directors' Resolution form is used by the board of directors in a corporation to document decisions and actions (typically) in place of a directors' meeting.. Alternatively, a Shareholders' Resolution is used by shareholders in a corporation to propose amendments, decisions, or changes to the corporation at a shareholders' meeting..
