Principles of Islamic jurisprudence, also known as uṣūl al-fiqh (Arabic: أصول الفقه , lit. roots of fiqh), are traditional methodological principles used in Islamic jurisprudence (fiqh) for deriving the rulings of Islamic law (sharia). Traditional theory of Islamic jurisprudence elaborates how the scriptures (Quran and hadith) should be interpreted from the standpoint of linguistics and rhetoric.

Islamic Jurisprudence [FIQH] Fiqh, the term for Islamic jurisprudence, is a process by means of which jurists derive sets of guidelenes, rules and regulations from the rulings laid down in the Qur'an and the teachings and living example of the Prophet Muhammad (pbuh), the Sunnah. Over the centuries, these have been formulated and elaborated upon by successive generations of learned jurists, through interpretation, analogy, consensus and disciplined research.
