Cost Disclosures Under Mifid Ii

The costs and charges disclosure requirements in MiFID II apply in addition to the Packaged Retail and Insurance-based Investment Products (PRIIPs) Regulation that requires firms to produce the standardised Key Information Documents (KID). Products that are Undertakings for Collective Investment in Transferable Securities (UCITS) are currently exempt from the PRIIPs Regulation.

In January 2018, MiFID II and the PRIIPs Regulation introduced new requirements for disclosing costs and charges. These aimed to make it easier for consumers to understand the total costs of investment products and services and required firms to disclose all costs and charges.

MiFID II's costs and charges disclosure has three key areas: 1. Immediate response to investor cost requests (before the event, also know as ex-ante) Annualised expected costs must be provided to all prospective investors before they make an investment decision.

Certain ESMA Q&As should be incorporated into the MiFID II Delegated Regulation (2017/565/EU) to foster convergence across member states. Ex-post disclosures should show both total costs and costs on an ISIN-by-ISIN basis (but with more optionality for portfolio management clients). Implicit costs should be included.

Alongside the introduction of PRIIPs, MiFID II introduces a requirement for firms to disclose an aggregated cost figure across a variety of investment products, including investment funds, derivatives and individual securities.

Under MiFID II, investment firms such as Rathbone Investment Management are obliged to provide clients annually with information about the actual costs and charges incurred by their portfolio. The provision of this information is known as an ‘ex-post costs and charges disclosure’. 2.

MiFID II ex-post costs and charges disclosure

MiFID II Costs and Charges requirements are expected to cover Retail funds, Private clients and Institutional funds with disclosure requirements for Ex-Ante, before the client invests and Ex-Post, periodic reporting after the client has invested into a fund, with the requirements for both these being enhanced from their current levels.

The disclosure requirements under IDD may be found in COBS 16A.4.2A, summarised below :

Reports on the service only applies when providing ongoing services (insurance distribution activities) after the conclusion of a contract. Reports must be provided at least annually.
