MMSEA Section 111 Mandatory Insurer Reporting

Pursuant to Section 111 of the Medicare, Medicaid, and SCHIP Extension Act of 2007 (MMSEA Section 111), the new mandatory reporting requirements apply to Group Health Plans that provide coverage to Medicare beneficiaries, as well as to liability insurance providers

(including self-insurance), no-fault insurance, and workers' compensation plans that pay settlements, judgments, awards or other payments to Medicare beneficiaries.

MEDICARE'S SECTION 111 MANDATORY REPORTING PROGRAM

On October 5, 2020 CMS issued an updated version of the of the MMSEA Section 111 NGHP User Guide. The latest version of the User Guide, version 6.0, clarifies the computation of TPOC amounts, confirms the fact that indemnity-only settlements do not need to be reported, and provides an updated list of excluded ICD codes for 2021.
