In this case, money will be taken off the amount you get, to cover the cost of the salvage value of the car.

The fact that the [vehicle] was damaged while in your possession is evidence that you failed to take reasonable care of it. I look forward to receiving, within the next 14 days, your written proposal to affect a satisfactory repair to the vehicle, at no

cost to me.
